2 **Nippard:** All right, the date is September the 4th, 2015, and it's 9:15 in the morning.
3 My name is Constable Michael NIPPARD, and I'm talking to Richard
4 DUNPHY. So Richard, I've come down here this morning, I don't have a
5 big lot to ask you, just a couple of things that, ah, come up. Um, after
6 Joe...Joe SMYTHE came here on that day.

7 **Dunphy:** Yeah.

8 **Nippard:** After that morning that he came here and he left, did you call, ah, Megan
9 or...or Don or anybody just to let 'em know that he...he was coming or
10 down here looking for him type thing?

11 **Dunphy:** No.

12 **Nippard:** No. And, 'because when he...if...I'm just trying to get the timeline right,
13 when he left, he went basically straight over there, is that right?

14 **Dunphy:** He wa...

15 **Nippard:** Joe.

16 **Dunphy:** He wasn't home at the time.

17 **Nippard:** Yeah. The first time.

18 **Dunphy:** We didn't mind where he went when he left.

19 **Nippard:** Yeah. Okay.

1 **Dunphy:** He was here to the door.

2 **Nippard:** Yes. Oh, so when he left you didn't mind where he went after that.

3 **Dunphy:** No.

4 **Nippard:** Okay. All right. And you didn't call just try to get in touch with Don to say
5 that –

6 **Dunphy:** No.

7 **Nippard:** - he was looking for him or –

8 **Dunphy:** No.

9 **Nippard:** - anything like that.

10 **Dunphy:** No.

11 **Nippard:** Or call Megan or anything like –

12 **Dunphy:** No.

13 **Nippard:** - that, hey? Okay. Ah, and the only other thing...other thing I wanted to
14 ask you about was the firearm. Ah, so there was three firearms that if I'm,
15 correct me if I'm wrong –

16 **Dunphy:** Yeah.

17 **Nippard:** - that Donald inherited when your father passed away. Is that right?

18 **Dunphy:** I don't know if he inherited or –

19 **Nippard:** Or he –

20 **Dunphy:** - well, okay, say he had 'em.

21 **Nippard:** Yes, he had 'em.

1 **Dunphy:** So he passed...I...there's two of them here.

2 **Nippard:** Two of them to you.

3 **Dunphy:** And that one was supposed to come here too.

4 **Nippard:** That one was supposed to come here too.

5 **Dunphy:** Yeah.

6 **Nippard:** Now was there any bullets with it?

7 **Dunphy:** (Unintel) that's a long time ago.

8 **Nippard:** Yeah. Hard to remember.

9 **Dunphy:** I...I can't see it because it was old. It was an old 22 it was.

10 **Nippard:** Yeah.

11 **Dunphy:** I don't...we don't know that see.

12 **Nippard:** Okay.

13 **Dunphy:** But he never did...it never did come here.

14 **Nippard:** (Unintel).

15 **Dunphy:** (Unintel) kind of...kind of fell out with us over time at...at that time and...

16 **Nippard:** Yeah. Do you remember if your father had any, ah, bullets for the 22?

17 **Dunphy:** We...we used...well, we used to use her when we were younger.

18 **Nippard:** Okay.

19 **Dunphy:** Okay?

20 **Nippard:** Yeah, that's right.

1 **Dunphy:** But I never seen him...he never used her. He ne...I don't know if he did
2 shoot with her or not then because he's younger than us. Ah, I don't
3 know. Might...I don't know. Could be but not, you know –

4 **Nippard:** Um-hum.

5 **Dunphy:** - 'cause for years it wasn't used, I knows that.

6 **Nippard:** Yeah. Very good.

7 **Dunphy:** No.

8 **Nippard:** Very...no, I think that's, ah, all I needed to ask you was those couple of
9 things –

10 **Dunphy:** Yeah.

11 **Nippard:** - that came up. That's all, just to see, ah, just trying to narrow down a
12 timeline, right? And you never heard anything over there obviously that
13 day.

14 **Dunphy:** No, 'cause we were here –

15 **Nippard:** Yeah.

16 **Dunphy:** - upstairs.

17 **Nippard:** Yeah. Yeah.

18 **Dunphy:** We went down, I think we happened to go down the road after.

19 **Nippard:** Yeah.

20 **Dunphy:** And he...what's his name? What did you say his name was? Joe –

21 **Nippard:** Ah -

22 **Dunphy:** - was there.

1 **Nippard:** Yeah. Yeah. Very good. What time is it now? Nine-eighteen.
