Okay, today's date is the, ah, 8th of November, 2016. The current time is, ah, 18:34 hours. Ah, my name is Constable Peter Gosse. I'm with the Major Crime Unit in St. John's with the RCMP and I'm here at the, ah, residence of Richard and Deborah Dunphy. Also with me is Corporal Steve Burke. Ah, good day. So, ah, what brings us here tonight, ah, Mr.

and Mrs. Dunphy is today, ah, the RCMP received a letter, um,

anonymous letter from, ah, Erin Breen, the lawyer for, ah, Megan Dunphy in regarding the shooting of Mr. Don Dunphy. So the letter, um, basically states that Mr. Dunphy, Mr. Donald Dunphy, had a friend, and this person is a friend of Mr. Dunphy who used to show up at his house regularly, ah, usually every day or so in a – in a boat. He used to come to the residence

daily in a boat. Does that ring any bells to you? Do you know anybody,

either one of you?
