09:00

I called Meghan DUNPHY, and updated her on the concerns she had put forward, yesterday. She was very appreciative of this.

09:45

In autopsy room, with Cpl. SEWARD and Cpl. LEE. Dr. AVIS and DR. DENIC came in and out of the room. There were two other medical staff present, as well.

11:58

E-mail received from S/Sqt. TILLER, who advised that he had taken the keys to the RNC veh. out of the exhibit room @ 11:30, and had handed them over to the Premier's detail at 11:58.

13:28

Once autopsy was over, I took possession of all exhibits from Cpl. LEE and Dr. AVIS. All items were placed in individual bags, and then placed in larger yellow bags. Clothing items would need to be dried, once back at the office.

15:48

All exhibits placed in main exhibit room with Cpl. SEWARD. Will be sorted and dried at a later date, as I was required to head down to the DUNPHY res. to meet with Chief Supt. BOLAND, Supt. SACHSSE, and S/Sgt. FITZGERALD.

17:15

10-7 at DUNPHY res., along with S/Sgt. TILLER.

Cst. REMILLARD is guarding the scene, and is told he can head back, as the scene will be released, once Chief Supt. BOLAND, Supt. SACHSSE, and S/Sqt. FITZGERALD have a look around. Meghan DUNPHY is on her way down to the residence at 18:30 to meet with myself and S/Sgt. TILLER.

Chief Supt. BOLAND, Supt. SACHSSE, and S/Sgt. FITZGERALD arrive on scene. Myself and S/Sgt. TILLER show them around the residence. Chief Supt. BOLAND advises us that the scene may not be released, after all, as an independent 3rd party may be called in to oversee the investigation. As it turns out, we will seek consent from Meghan to use the residence, again.

18:40

Megan DUNPHY arrives, along with her boyfriend, Billy CORCORAN. She is updated on these latest developments, and is happy that a 3rd party is being brought in. She has no issues with the police using the house, again.

I, then, help Meghan feed the cats in the house, in the shed, and in the pen, up on back of the res.

19:20

Meghan and CORCORAN leave.

20:20

Myself and S/Sgt. TILLER look around the house, and make sure that both doors are locked. We found DUNPHY's wallet, inside a coat, that was hung on a kitchen chair. Meghan had mentioned that she would like to have this.

We leave the scene, unguarded, but leave the police tape up.

20:30

Call Meghan, but no answer. Mailbox is full. We want to update her that we have her dad's wallet, and that we will be dropping it off to her.

20:40

Call Meghan, again, but no answer.

20:50

Drop by Meghan's house, but nobody is home.

21:00

Wallet is locked up in my personal locker, and will be dropped off tomorrow.

End of day.
