2 **Burke:** Today is, ah, 2016, ah, 11-08. The time is, ah, 16:23 hours. My name is
3 Corporal Steve Burke. I'm with the RCMP Major Crime Unit in St. John's.
4 I'm currently at the office of, ah, Bob Simmonds on Duckworth Street and
5 present is, ah, Meghan Dunphy and, ah, Constable Peter Gosse, also of
6 Major Crime Unit. Ah, Meghan, ah, I'm going – going to talk to you today
7 about a letter that the, ah, that, ah, Ms. Breen received originally and that
8 we have in our possession now. The letter, ah, states that a person
9 witnessed the event that happened in Mitchell's Brook and, ah, he – the
10 person claims that he was a friend of your father's and, ah, visited him on
11 a daily basis...

12 **Dunphy:** Um-hum.

13 **Burke:** ...by boat. Can you tell me anything about this person, this letter or, um...

14 **Dunphy:** No.

15 **Burke:** Any information that you can offer would be of...

16 **Dunphy:** I have no idea.

17 **Burke:** Okay. Do you know of anyone that would visit your father on a daily
18 basis?

19 **Dunphy:** Well, there's people who'd visit on a daily basis, like Tom Hearn and Colin
20 Dinn would be – not like every day but on, you know, he'd – they were
21 there often, and the people who bought Pop's house would be there.
22 That's basically it.

- 1 **Burke:** Who – who bought...
- 2 **Dunphy:** Ah, Dominic and Rita Farrell, so they're in on weekends. They would be
3 probably the only people who were around Dad's.
- 4 **Burke:** Ah, do you know of anyone that would have visited your father by boat?
- 5 **Dunphy:** No, not at all.
- 6 **Burke:** Around your ar – your father's house or in Mitchell's Brook is there a dock
7 or anywhere to...
- 8 **Dunphy:** There's a wharf a couple minutes up the road, like, a big – they have
9 barges and stuff tied on there. It's not like – fishing boats don't go in there
10 or anything I don't think.
- 11 **Burke:** Okay.
- 12 **Dunphy:** And there's some private docks down through Mitchell's Brook where
13 there's some cabins and that.
- 14 **Burke:** And if a person did, ah, visit your father by boat, ah, would you know
15 about it?
- 16 **Dunphy:** He would have told me obviously if someone was coming to visit by boat.
17 He told me whoever visited really...
- 18 **Burke:** Right.
- 19 **Dunphy:** ...so, yes, I believe I would have known.
- 20 **Burke:** Okay. Ah, given that, is there anything you can add to what you already
21 told me?
- 22 **Dunphy:** No, I – I don't know anything about the letter at all, just that it was given or
23 mailed into Erin.
- 24 **Burke:** Right.

1 **Dunphy:** That's basically it.

2 **Burke:** Ah, Mr. Simmonds is there anything you want to add to...

3 **Simmonds:** No.

4 **Burke:** Okay, ah, you got any questions, ah, Constable Gosse? Okay if, ah, you
5 don't have anything else, ah, we'll end the statement.


6 **Simmonds:** (Unintel).
