Report:

12:00 hrs. I attended the WSCC office and obtained an audio recorded statement from Mr. Thomas Gregory MAHONEY (██████████). My MAHONEY provided the following information: [N.B. All times are taken from Mr. MAHONEY's cell phone as well as emails he sent and received]

- He is the Executive Director for Workers services and is also responsible for Corporate Security.
- He was authorized to speak to Sgt SMYTH as well as myself by way of Section 39 of the Privacy Act (He provided me a copy of this legislation for the file).
- He received a cll this past Saturday at 3:28 from Mr Ralph TUCKER who is the Chairman of the Board requesting information on Donald DUNPHY. He did not tell Mr. TUCKER that he (TUCKER) did not have authority to be told this information but that he could provide it to the Police. He directed TUCKER to have Sgt SMYTH contact him directly.
- After hanging up with TUCKER, he Craig NOSEWORTHY to provide the contact info for Mr DUNPHY.
- At 4:07 p.m he called Sgt SMYTH and provided contact information for the Donald DUNPHY that was a client of Workers. Sgt. SMYTH asked whether there had been any issues with this person and he told SMYTH that there had been no threats but that he was aware of Mr DUNPHY because approximately 2 weeks ago he was made aware of some things that DUNPHY had been posting about an employee (Steve PHILLIP's) and how he had handled his claim years ago. There was certainly nothing threatening with the tweet but he did forward it to "legal" as an employee's name was noted. He also directed his staff to monitor the person's tweets in the event something else came up. He is aware of no threats that Mr DUNPHY had ever made towards anyone in his office. The comments he did make were disparaging but not threatening.
- Sgt. SMYTH told him "I think I'll have to pay him a visit".
- The phone call with Sgt. SMYTH was very brief (Less than 5 minutes) and this effectively ended his involvement with the matter.
- On Sunday at 6:07 p.m he received a call from Leslie GALWAY who is the CEO of the commission. She asked him to forward his email correspondance to her as there had been a shooting involving Mr. DUNPHY.

12:30 hrs. Statement is concluded. Mr. MAHONEY asked that I review both his phone and his computer to confirm that the information he had provided is accurate.

1330 hrs. I returned to the office and prepared this report along with a CD containing the audio recording of the interview. I forwarded this information to Cpl FOOTE (File Coordinator) along with the emails provided by Mr MAHONEY.
