Therefore, I did request the audit search myself and can provide you with the following:

The Name DONALD DUNPHY does not appear on any query logs on the RMS system between the dates April 3<sup>rd</sup> – 5<sup>th</sup>, 2015.

To clarify, the name DONALD DUNPHY was not indexed into the RMS during that time period. Meaning if the name was queried, the audit log system would not show if anyone made an attempt to query the name Donald Dunphy.
