Hi Dale,

I received the below email today from Cpl. Steve Burke who is an investigator with the RCMP HQ Major Crimes Unit. He is one of the investigators investigating the fatal police shooting of Mr. Donald Dunphy. As a result of interviewing A/Sgt. Joe Smyth, Cpl. Burke requires several things from our department for their investigation. I am the liaison between the RCMP and the RNC on this matter.

On Easter Sunday, April 5th, 2015 Smyth went to see Mr. Dunphy at approximately 230 pm but before doing so he conducted some ICAN queries, and then contacted Comm Center for CPIC queries. He has also filed a report in ICAN under file number **2015-17896**.

Can you please prepare a couple things for the RCMP. They will need :

- An offline search conducted on CPIC to get the search and the hits/results from the RNC that Joe Smyth conducted, or the Comm Center. (They could do it but are asking us to provide this document)
- Conduct a query on what Joe Smyth checked/queried on ICAN, and any results, before he attended to Mr. Dunphy's residence. (I assume he checked his name to see if there were any files on Mr. Dunphy.)
- Provide a copy of everything from ICAN on file number 2015-17896 and further confirm that this is Joe's file regarding the Twitter threats against MHA Minister Collins and Premier Davis. (Joe gave me the file number and he may have made a mistake due to being shaken over this situation.)

Can you please confirm that you have received this request and are able to provide the action required.
