I have attached the e-mails concerning Mr. Dunphy and the threatening Tweets I was cc'd on starting on Friday.

I have also attached a BBM conversation between myself and Joe today both before and after the shooting. In the conversation when he says, "the P" he is referring to the Premier. As well, when I tell him to message me after he speaks with Dunphy I am expressing concern that someone knows where he is and what he's doing, that is why he replied that he had contacted Holyrood (Detachment). The next message is where he indicates that he was just involved with a shooting.

I had no other conversation, BBM or otherwise, with Joe or anyone else concerning Mr. Dunphy, the tweets or the investigation.

Do you require a further written account beyond this e-mail? I don't have anything to add, I received the attached e-mails, did not reply, and had the attached BBM conversation.
