2 **Burke:** Ah, today is, ah, 2016-11-08. The time is 16:28 hours. My name is
3 Corporal Steve Burke. I'm with the RMCP Major Crime Unit here in St.
4 John's. I'm currently at the office of Bob Simmons on Duckworth Street.
5 Ah, also present is, ah, Constable Peter Gosse, and I'm interviewing, ah,
6 Bill Corcoran. Did I say that right?

7 **Corcoran:** Yeah.

8 **Burke:** Ah, Bill, you're the common-law partner of Meghan Dunphy?

9 **Corcoran:** Yes.

10 **Burke:** Ah, just to let you know that, ah, Ms. Erin Breen received a letter from an
11 anonymous person regarding information, ah, for, ah, regarding the
12 shooting of, ah, Don Dunphy. This person, ah, the writer or the author of
13 this letter claims that he was a friend of Don Dunphy's and would visit him
14 on a daily basis. Can you offer any, ah, knowledge or insight into the
15 author of the letter or of any information regarding the letter?

16 **Corcoran:** No.

17 **Burke:** Ah, do you know of anyone that would visit, ah, Don Dunphy on a daily
18 basis?

19 **Corcoran:** No sir.

20 **Burke:** This person claimed to visit by boat. Can you add anything to that?

21 **Corcoran:** No.

1 **Burke:** Is there an area where you would dock a boat in near Don Dunphy's
2 residence?

3 **Corcoran:** Not that I know of, no.

4 **Burke:** Ah, Don Dunphy's residence is across the road from the ocean basically.
5 Is there any way you can dock a boat along that shoreline?

6 **Corcoran:** I'm not familiar with boats, b'y.

7 **Burke:** Okay.

8 **Corcoran:** I don't know anything about it.

9 **Burke:** Okay. Yeah, like I said, the letter is anonymous and we don't – we're not
10 – we don't know the author yet, and can you offer any information given
11 what I've told you...

12 **Corcoran:** No.

13 **Burke:** ...to who that would have came from.

14 **Corcoran:** No idea.

15 **Burke:** Okay. Is there anything you want to add to what you told us here?

16 **Corcoran:** No sir.

17 **Burke:** Ah, Mr. Simmonds?

18 **Simmonds:** (Unintel).

19 **Burke:** Constable Gosse, anything else you can add?

20 **Gosse:** No.

21 **Burke:** Okay. The time is 16:32, and that's the end of the statement.
