Report:

11:35 hrs. Cst NIPPARD and I attended the RNC Headquarters building and conducted an audio recorded interview with A/Inspector Mike ADAMS. Inspector ADAMS provided the following information regarding his involvement in this matter:

- He is the acting Inspector in charge of Patrol Division.
- S/Sgt TILLEY called him to advise that he needed to return to HQ at 1442 hrs.
- He was advised that there had been a shooting in Mitchells Brook. According to the information he received, Sqt. Joey SMYTH had been involved and he had called the RCMP and an ambulance.
- He made calls to upper management to advise and confirmed that as this had occurred in RCMP jurisdiction, they would lead the investigation.
- He and S/Sat TILLEY determined to attend to lend support to Sat SMYTH (Inspector ADAMS is a Critical Incident Debriefer) and to check on his well-being.
- While enroute he called SMYTH who advised him that the RCMP were enroute.
- Before they arrived in Mitchells Brook, he received a call from D/Chief SINGLETON who told him that Joe was being brought to the RCMP Detachment in Holyrood and they should meet him there.
- Upon arrival at the detachment, he met with S/Sgt Rod TILLER and advised him that the RNC members were not there to interfere in any way with the investigation but were there to lend support to their member. He emphasized that he did not want to be informed of any details of the investigation as this was outside of his role. TILLER was very accommodating and provided them a place to wait for SMYTH.
- He also assisted S/Sqt TILLER in contacting the SPCA as there was some issue with cats at the residence and he had a contact with the SPCA.
- When SMYTH arrived, he along with S/SGT TILLEY and SMYTH went into an office upstairs. He conducted a critical incident debriefing with SMYTH and encouraged him to avail of the Employee Assistance Program.
- SMYTH was shaking somewhat but was very eager to provide his account. ADAMS encouraged him to wait until he had calmed down and collected his thoughts. Although ADAMS discouraged SMYTH from telling even the RNC members what had happened, SMYTH was persistent and stated that:
 - o He was there on an investigation
 - o He had advised the RCMP prior to attending the scene.
 - o He was concerned for the man because of the conditions in which he was living.
 - o He noted a bat or stick near the man and paid some attention to it while he spoke to him.
 - o While Joe was writing on his file, DUNPHY became agitated.
 - Dunphy pulled a gun out and Joey said "no no no no"
 - He believes he may have shot 3 or 4 times.
- ADAMS believes he may have been with SMYTH for about an hour.
- He left and was assured that Warren SULLIVAN would provide him a ride home.
- He noted that he didn't write notes while he was with SMYTH as he wanted to ensure SMYTH understood that he was there in his capacity to provide support and a critical incident debriefing.
- He prepared notes after returning to the RNC building (Copy of these notes provided to Cst NIPPARD and added to the file)
