I received a call from Telecoms, requesting that I call S/Sqt. TILLER, as there had been a shooting.

15:20

I called S/Sqt. TILLER, and he stated that there had been a shooting, near Mt. Carmel, and that an RNC was involved. He advised that there would be a debrief at the Holyrood office.

16:15

10-7 at the office, and speak with S/Sgt. TILLER. Two members from the RNC were present, as well.

16:45

I called Dr. DENIC (ME), and updated him on what we had. Dr. DENIC thought that the body was already at the hospital. He was updated that Cpl. FOOTE was at the scene, with the body, as we speak. Dr. DENIC would like an update, when more info is known: how many shots were fired?, from what distance?, etc.

Dr. DENIC said the autopsy will be conducted tomorrow at 0900.

17:00

Debrief at Holyrood office, with: S/Sgt. TILLER, Sgt. OSMOND, Cpl. HENSTRIDGE, Cpl. SEWARD, Cpl. BURKE, and Cst. NIPPARD.

I was assigned the task to complete the ME 1, and I will attend the autopsy, along with Cpl. SEWARD.

A short while later, I was advised, by Cpl. BURKE, that I would be the exhibit custodian. I was to seize the clothing, worn by Sgt. SMYTH. Someone is en route with a change of clothes for him.

18:50

I accompanied SMYTH into the male changeroom, at the Holyrood office. I seized all his clothing, except his under wear. The following items were seized:

- 1. 1 pair of brown casual pants
- 1 black, long sleeve, polo shirt
   1 pair of black ankle socks
- 4. 1 brown v-neck t-shirt
- 5. 1 pair of brown leather shoes
- 6. 1 brown leather belt

All exhibits were placed in the far right exhibit locker, with the assistance of Cpl. SEWARD. Sticker was placed over the seam of the locker to show continuity.

20:40

10-7 at the scene, with Cpl. SEWARD. Speak with FIS members, Cpl. LEE and Sgt. SAUNDERS. They will photograph the scene, first, and then we will go inside and seize any exhibits.

Following members were currently on scene: S/Sgt. CONOHAN, Cpl. O'KEEFE, Cst. COX, Cpl. FOOTE, Cst. CRUMMEY.

21:21

Cpl. SEWARD called Gibbons Funeral Home, and updated them on the file. They are on standby.

21:40

I called Dr. DENIC, and updated him on the file. He would like photos of the scene, before the autopsy. I told him I will check with Cpl. LEE.

21:50

Cpl. O'KEEFE hands over lockbox, belonging to SMYTH, which he had seized, earlier. This was done in the backseat of the Ford ELV. Cpl. SEWARD was also present.

Cpl: O'KEEFE opened the box, and the contents were checked:

- 1. 1 black pistol, in lockback...Cpl. O'KEEFE had cleared the gun when he seized it. No mag in the gun.
  - 2. 2 black mags...1 mag is laid flat. Cpl. O'KEEFE had done this to indicate that this was the mag that was in the gun, at the time it was seized
- 3. 1 can of OC spray, still in its pouch

The box was locked, again, and I seized the keys from Cpl. O'KEEFE. I also seized the keys to SMYTH's veh., from Cpl. O'KEEFE. SMYTH's veh. is still in DUNPHY's driveway.

Cpl. O'KEEFE advised that the NOK was Meghan DUNPHY

682, lives on Salmonier Line. Cpl.

O'KEEFE said that the deceased did not work, and was on disability.
