Thanks Mike,

The exhibit numbers for the two shirts are as follows:

PE-21: blue and white short sleeve golf shirt.

PE-22: blue and black long sleeve shirt, which was worn over the short sleeve golf shirt

It would be great if we could recover the serial number.

The exhibit number for the magazine, which was in the pistol, is PE-37.

The exhibit number for the magazine, which was not in the pistol, is PE-38.

The exhibit number for ammo is PE-39.

The firearms have been unloaded, and the magazine has been taken out of the pistol. The pistol is in the "lockback" position, and both have had trigger locks placed on them. Other than that, they have not been disassembled, or test fired.

I have been speaking with NWEST, who will add a report to our file. I will be forwarding pictures of the rifle to NWEST, along with the barrel specs and the name and DOB of the previous owner, in hopes of getting a history

on the rifle.

I just left a message on your detachment's voice mail.

- I just need exhibit numbers for the 2 shirts before I can approve them.
- We won't need to look at the jacket, since there's no visible blood-like staining on it.
- As for firearms packaging, the Approval Notice will include instructions.
- I can add a request for Firearms Section to attempt recovering the serial number.
- Yes, to the officer's sidearm / ammunition. Please package the empty magazine with the sidearm, and the ammunition separately, and please provide an exhibit number for the ammo. Also, could you please confirm:

- Have the firearms been disassembled or manipulated in any way, or are they in the condition they were when seized?
- Have the firearms been test fired?
- Did you get an opinion from another unit (NWEST for example) regarding any aspect of the firearms' evidence; the firearms' mechanical condition, barrel length or legal classification for example?

Hi Sgt. Merritt,

I am in the process of getting the exhibits, for this file, ready to be sent to the lab. I noticed in your correspondence with Cst. Mike NIPPARD, you had the following questions:

All this being said, I'm ready to approve all your other exhibits, but first need to know:

- ***PE9: Is there visible blood-like staining on the complainant's jacket?***
- ***PE9: If yes to above, do you have a known sample of the deceased's DNA / can you confirm only one bleeder in this incident?***
- ***PE10: If you indicate which article(s) of the deceased's clothing were hit by gun fire, I can approve it / them for ballistics testing.***
