Details - Détails

On 2016-11-09, I received a call from Cpl. Steve Burke of Major Crime Unit East. He advised that he had high priority exhibits he wished to have processed for fingerprints. I advised that I would be at headquarters the following day (2016-11-10) and I could get them from him directly at that time.

On 2016-11-10, I attended the Major Crime Unit office at B Division headquarters, and Cpl. Burke handed over the exhibits (at 12:24 hrs), namely 2015376186PE41, a 2-page handwritten letter, and 2015376186PE42, the envelope in which the letter had been contained. Cpl. Burke advised that the letter had been received at a lawyer's office prior to coming into police possession. The letter had been handled by personnel at the law firm. I advised that I would process the items, and then determine if elimination fingerprints would be required from the personnel. Cpl. Burke advised that the items may be required for possible DNA examination following the fingerprint examination.

Upon returning to the FIS office, I secured the exhibits in our main exhibit locker.

2016-11-14, 13:15 hrs: I spoke with Kelly Hendriks of the Forensic Assessment Centre regarding the processing of these exhibits to ensure none of my processes would interfere with potential DNA recovery. She advised that there was no risk, and to proceed as I normally would.

13:30 hrs: I began processing the exhibits. I photographed all items (the envelope and both pages of the letter), front and back. I then processed the items with DFO.

14:45 hrs: Following the completion of the DFO process, I viewed and photographed the items under normal light and under the forensic light source. I noted several areas of development, however there were no impressions with any detail, i.e. no friction ridge impressions were developed.

15:15 hrs: I then treated the items with ninhydrin. I examined the items and noted no further development i.e. this second process did not yield any identifiable friction ridge impressions. I photographed the items again.

15:45 hrs: I spoke with Cpl. Burke by telephone and advised of the results of the fingerprint examination. I advised that I would return the items to him on 2016-11-16.

2016-11-16, 13:40 hrs: I returned the exhibits to Cpl. Burke at the Major Crime Unit office in B Division Headquarters.

No further FIS action is required.
