Present protocol as it relates to the PPD:

Since February of 2016, when a request is received for protection duties or when threats/harassing comments are made against a minister, the Premier's Office contacts the Office of Intelligence & Organized Crime, namely A/Insp. Joe Gullage or Sgt. Glenn Noseworthy, who will generate a file in relation to the request and assign to an investigator in Intelligence & Organized Crime for follow-up.

The following members are assigned to these tasks: Cst. Jessica (Singleton) Brown, Cst. Jason Power, Cst. Scott Haye or Cst. Shawna Walsh. All of these officers, with the exception of Cst. Shawna Walsh, are trained in V.I.P. Protection Detail and can be assigned to V.I.P. Protection; however, most of these assignments for V.I.P. Protection in and out of the Province are usually handled by Cst. Jessica (Singleton) Brown because of her previous experience of over five years working with the PPD Section as a secondary duty.

No members are assigned to the Premier on a full-time basis and V.I.P. duties are considered as secondary duties. The RNC also has two members in the Corner Brook Detachment; namely Cst. Danny Abbass and Sgt. Ryan Wentzell have been trained in V.I.P. security and may be assigned to Protection Services Detail on the West coast if required.
