

1800 [] Justice David Ritchie attended
B Div HQ. I escorted him from front
entrance to PPO.

Asked how he was doing, explained health
issues both he and his wife. Felt this
incident was taking a toll on their health.

I informed him that I had been trying
to meet with him for some time prior to
meeting with family and public announcement
of findings. Ritchie advised he and his
wife were on holidays outside of country.
When they came back health issues
have rose.

I went over the final report with him
pointed out how he received all the
info along the way & conclusion
summed up the investigation. He
read this in front of me. Ritchie
talked about his report, and that
he was not wanting to have to deal
with an enquiry but then went on to
ask about possible remuneration. He
was talking about his need to understand
what happened. I explained to him
that as investigators we gather the

evidence and that is what we make our decisions off of. I explained to him that we did not ask him to be a judge but an observer. He said he wanted to get to the bottom of what happened. He talked about regretting ~~you~~ speaking with media (said they came to him) I explained that although I reminded him during all of our meetings throughout the investigation of his mandate, I could not direct him in any way as it would defeat the independence we were requesting.

I explained to him as we concluded that I had noticed on one of his interviews with Fred Holton, confidentiality was discussed. I provided Justice Riche with a signed copy of his original contract/agreement terms of reference. I stated that this was his second copy as I had given him one upon original signing (April 2015). He read and read the confidentiality section aloud and acknowledged understanding
