The attached material is what members of the RNC are taught in relation to U/F, and reviewed by the members every three years.

Module 1, firearms training is mandatory each and every year by all members.

Module 2, is review of Control Tactics (handcuffing, baton, oc spray), this would be a hands on session in a gymnasium.

Module 3, is refresher in REACT (rapid entry active criminal threat), front line officers only.

Module 4, is the material attached. This is sent to all members for review and respond if they have questions.

This year members are to do Modules 1 and 4. Next year will be 1and 2, the following year 1 and 3.

I believe Cst. Smyths training record was forwarded already. Firearms training for him for the past 5 years are as follows : 2010 completed on 2010- 03-25, 2011 completed on 2011-03-30, 2012 completed on 2012-12-07, 2013 completed on 2013-10-28, 2014 completed on 2014-04-17. Cst. Smyth has completed firearms requalification without any problems.

I have no incidents of issues in relation to Cst. Smyth. All use of force reports end up on Deputy Chief Singleton desk for final review. If the Deputy feels a use of force report needs further review he would forward same to the use of force unit for follow up.
