

Re-enactment Video Notes:

- 2pm arrives Mitchell's Brook.
- no one at SOC's
- speaks to neighbours (brother + sister-in-law)
 - gets family history - (admits to ~~act~~ - no career - a bit reclusive)
- leaves and sees blk cherokee in driveway and decides to try again.
 - looks in the window and marks a window #15 sees DUNPHY operator and wife SMYTHE in
 - They make small talk in the hallway and move into living room



- ply wood
- SMYTHE stands by fireplace
- DUNPHY sits in lounge chair just inside doorway
- Disjointed conversation for about 5 mins
- he get agitated
- dried saliva in mouth.

- so he forced the toilet in his hands

- SMYTHE sees the gun come from the right side of Murphy's chair and sees the barrel of the gun move towards him

mainly toward the door. - arm extended
- he recollects Dupluy's head
moving from the impact
- estimate of 2 seconds from seeing gun &
arriving in the hallway
